

Key Responsibilities and Duties

Application Analysis:

- ▶ Determine operational objectives by studying business functions, gathering information, evaluating output requirements and formats
- ▶ Analyse requirements, construct workflow charts and diagrams, study system capabilities and write specifications in the development of new programs
- ▶ Determine standards and procedures regarding the change of and implementation of new applications.
- ▶ Define project requirements by identifying project milestones, phases, and elements, forming project team, establishing project budget (High Level)
- ▶ Determine the suitability of current and potential applications to the company environment and make the appropriate recommendations.
- ▶ Provide references for users by writing and maintaining user documentation, providing help desk support, training users

Functional & User Requirements

- ▶ Perform system testing
- ▶ Identify problems and new business requirements
- ▶ Build and maintain relationships with application service providers to ensure the company optimizes value from system changes and additions.
- ▶ Act as the central repository for all company business processes and change authority for any changes to any IT processes
- ▶ System Administrator on Core systems
- ▶ Create new users on system
- ▶ Maintain all users on all systems

Stakeholder Co-ordination or Engagement

- ▶ Co-ordinate and Manage workshops related to all critical systems between internal staff and external
- ▶ Manage Information Technology projects specifically for business applications, including either third party or developed implementations, and following the best practices for the System Application Development Lifecycle

Reporting/Documentation

- ▶ Plan and document system flow from the ground up, example Business Requirement Spec (BRS)
- ▶ Write and document technical requirements
- ▶ Assist with extracting relevant business reports should there be a system problem
- ▶ Documenting existing processes
- ▶ Business management statistics – Including user access security

Communication

- ▶ Interact with internal users and customers to learn and document requirements that are then used to produce business requirements documents.
- ▶ Co-ordinate and Manage workshops related to all critical systems between internal staff and external

Miscellaneous & General

- ▶ Perform any other work-related duties and responsibilities that may be assigned from time-to-time by management

Qualifications

- ▶ Bachelor's degree in computer science or information technology, or equivalent experience.
- ▶ 2-3 years' experience working with information technologies and systems analysis.

Knowledge & Skills

- ▶ Strong computer, hardware, software, and analytical skills
- ▶ Experience with applications such as Salesforce and MS Dynamics will be advantageous
- ▶ Ability to switch between tasks quickly and stay in control of problematic situations
- ▶ The job involves working on multiple projects at any time, often within a broader business team.
- ▶ Experience in Telephony leads distribution
- ▶ Experience with system applications (Insurance)
- ▶ Excellent communication and interpersonal skills, both written and verbal
- ▶ The ability to relay technical information to non-technical users and elicit clients' needs customer service skills.
- ▶ Problem-solving ability analytical skills
- ▶ The ability to establish rapport with stakeholder's attention to detail

- ▶ The ability to work independently but also as a part of a team project-management skills.
